

0 - 7 = ...+1.8?!

If you think those numbers don't add up, you're not alone. Even Manchester City Council, which had tried to tell the public it had reduced carbon dioxide emissions, has conceded that their carbon emissions have actually increased. In a dramatic admission at Neighbourhoods Scrutiny Committee on Tuesday 16th July, Nigel Murphy, the elected member for responsibility for climate change action admitted that the Council's emissions have increased. Responding to a question based around Friends of the Earth's submission to the committee, Councillor Murphy conceded that - contrary to a press release released by Manchester City Council - like-forlike carbon dioxide emissions from the City Council's operations have gone up by 1.8% in the past year, and that the actual amount saved over the last three years is 5.2%, not the 14% initially claimed.

Executive Member Nigel Murphy responded to a question by Cllr James Hennigan by telling the assembled councillors and members of the public that he was willing to agree with Manchester Friends of the Earth's analysis as long as it was noted that the Council has been sourcing its energy from "decarbonised sources."

The Friends of the Earth submission, sent the

The Friends of the Earth submission, sent the previous night to the chair of the Committee included the immortal lines "Achieving the operational and cultural changes to radically reduce greenhouse gas emissions is clearly not a simple task and will require dedicated and continuous action. it will also require a

commitment to transparent and meaningful progress reporting."

It continued "We therefore call on the Neighbourhoods Scrutiny Committee to request that the Annual Carbon Reduction Plan be amended to clearly state that there was a 1.8% increase in like-for-like emissions between 2011/2 and 2012/13, and that there has only been a 5.2% reduction in like-for-like emissions against the 2009/10 baseline."

MCFly has over the last weeks repeatedly asked the City Council if the 2013/14 Annual Carbon Reduction Plan going to be redrafted to include more ambitious targets, so that the Council meets its "20% by 2014" reduction target. We have also asked "when did 2009/10 become the agreed baseline year for the Council's emissions? In the Manchester Climate Change Action Plan, agreed by the Executive on November 17th 2009, goal one was a 41% reduction on carbon dioxide emissions by 2020 from a 2005 baseline."

In its finest traditions of openness and accountability the City Council has, at time of going to press, given us no statement.

What is to be done?

You could give up – no-one would blame you, given the contempt that the City Council is (forever) spewing on you. Alternatively, turn to page 4 for MCFly's suggestion.

First Time Reader?

Climate change is coming harder & faster than scientists thought. It's caused by our use of oil, coal & gas. Manchester will not be immune. We have three choices: we can bury our heads in the sand, we can *talk a good game* or we can cut our energy use & massively increase our resourcefulness. ENVIRONMENTAL SUSTAINABILITY SUB-GROUP TO MEET

The "Environmental Sustainability Subgroup" of Manchester City Council meets for the first time at 11.30am on Wednesday 7th August. The meeting, which is open to the public [no need to book], will take place at Manchester Town Hall, and is the first of three for the ad- hoc group. The next two meetings will be on Wednesday 2nd October and Wednesday 6th November. Presumably also at 11.30am, and venue to be confirmed

Councillor Kate Chappell, who chairs the group, told MCFly "Sustainability is vital to Manchester's future. We know from Professor Kevin Anderson that there are no simple fixes. This subgroup will provide councillors with the chance to properly consider and discuss some of the most complex issues, and to begin to chart a path forward."

As reported previously, the group is forming in response to unfinished business from several well-attended and positive meetings of the Economy Scrutiny Committee. This committee, one of the six scrutiny committees, mainly looks at employment, education and skills. Given the lengthy list of reports the ESC already had on its "forward plan", the proposal at the May 2013 meeting to establish a sub-group (made initially by Liberal Democrat Victor Chamberlain) was warmly welcomed.

The membership of the subgroup is; Councillors Chamberlain, Kate Chappell (Chair), Basil Curley, Daniel Gillard, James Hennigan, Suzanne Richards, Carl Ollerhead, Chris Paul, Fran Shone, Andrew Simcock and Angeliki Stogia.

Perhaps they will find the time to look revisit the question of all six of the Scrutiny Committees looking at different aspects of climate change and how it will affect Manchester, or at the many suggestions that were put to the Neighbourhoods Scrutiny Committee in July. By the time you read this, there'll be more details on the MCFly website. manchesterclimatemonthly.net

"If you need a job doing... A Citizens' Climate Plan.

In July 2014 a "three year plan" for Manchester City Council"s climate goals will be agreed at Scrutiny and then signed off by the Executive. Going on the quality of both the plans and the "actions" in the various Annual Carbon "Reduction" Plans since 2010, this three year plan is likely to be both unambitious and then *unimplemented*.

Currently there is a low-level of awareness/concern both within and beyond the Council over the obligations and opportunities around the climate change.

There is little sense among Manchester activists of what they can do to lower Manchester's emissions and help make the city more resourceful and responsive, with actions focussing on worthy personal actions such as going vegetarian or (re)cycling.

So, what is to be done? Well, we here at MCFly think that people who give a damn – whether they are Labour, Green, Lib Dem or "a plague on all your houses" - need to get together to <u>create a **Real**</u> <u>Climate Plan</u> that we can then give to the Council by the end of April 2014.

The Council can then draw upon that document to make a robust and radical 3 year plan that gives them a real chance of hitting their targets, not just for carbon reduction, but also culture change.

The three alternatives – to keep on staging emotathons (see page 5) and feel-good smuggery, to do small-scale stuff that is good on its own but not fit for the scale of the problems, or endlessly critiquing without proposing – is not going to help us all pass the "mirror test"* ten years hence.

Context

In 2012 Manchester City Council aimed for a 10% reduction in its own emissions . In July 2013 it claimed a 7% reduction. It was able to do this because responsibility for traffic lights moved from its books. Looking at everything else (buildings, transport) emissions went ... UP by 1.8%.

So, building on that extremely strong base, the Council's bureaucrats have proposed a series of actions to help them hit a new "7%" target. You can see the complete list here. Manchester Climate Monthly is going to take a closer look at

Apparently there will be a "Stakeholders Conference" on Thursday 6th March next year. More plasticine will be played with, no

Meanwhile, the charity Action for
Sustainable Living has taken over
the "secretariat" role for the Steering
Group from the breath-takingly
incompetent "Groundwork." We sent
AfSL a couple of very straightforward
questions;

a) what do you understand by the bullet point "Managing the 2013/14 Steering Group election process?" [in the tender document circulated by Manchester City Council when it was asking organisations to compete for the honour of being the SG's secretariat]. Could you unpack that for us please? When will elections be held? For what roles? How? b) what do you think of Groundwork's legacy with "maintaining and updating the MACF website" - given that as of July 25th 2013 the "events page" refers to upcoming events in August... 2012. Will you be doing better?

We sent these questions twice in the weeks before publication. AfSL has not deigned to reply yet. We shall persist.

The Neighbourhoods Scrutiny Committee, one of six scrutiny committees tasked with keeping tabs on what the Council is up to has decided to set up a subgroup to look at the thorny issue of recycling and waste-collection. It's bin a long time coming...

The Environmental Strategy Programme Board met (in private) on Monday 5th August. Expect the minutes to go up sometime next year. Green and Blue Infrastructure Plan – the ever-delayed plan is finally due to be scrutinised in early September, despite Richard Leese telling the Liberal Democrats at the last full Council meeting that it would be going to scrutiny in July.

Meanwhile, the "Meanwhile Strategy" (about land that is eventually going to be developed but might be put to decent use until then) alluded to in last year's Annual Carbon "reduction" plan has been downgraded. It will now be a couple of anodyne paragraphs in the aforementioned GBI plan.

Uplifting news; Manchester City Council spent, over the course of four years, a quarter of a million quid. on the post of "Head of Environmental Strategy." When they abolished the post earlier this year, they didn't undertake any review to see if they'd got value for money, or what [if anything] would be lost by abolishing the post. For that kind of money we could have had a pop concert from Rhianna, or Alicia Keys! See MCFly website on a Slow News Day in August for more info.

In more uplifting news, Manchester Veg People's crowd-sourcing efforts were successful, and they will be getting themselves a new van.

And in downlifting news, these from the Guardian-

10th July "The world is currently on course to exploit all its remaining fossil fuel resources, a prospect that would produce a "different, practically uninhabitable planet" by triggering a "low-end runaway greenhouse effect." This is the conclusion of a new scientific paper by Prof James Hansen, the former head of NASA's Goddard Institute for Space Studies and the world's best known climate scientist. The paper due to be published later this month by Philosophical Transactions of the Royal Society A (Phil. Trans. R. Soc. A) focuses less on modelling than on empirical data about correlations between temperature, sea level and CO2 going back up to 66 million years." **2nd August** A new study from scientists in the US controversially draws a link between increased rates of domestic violence, assault and other violent crimes and a warming climate.

Politicians at loggerheads with each

other, but with an Almighty (?) Leader. Officers of different calibres, some climbing the greasy pole while others struggle to Do the Right Thing. Scrutiny Committees that sometimes bite, and sometimes well, bite.

This novel is **not** set in Manchester, and has alcohol abuse as its theme rather than climate change (there is one funny/knowing reference to carbon dioxide reductions). It is, however, well-worth the time of any climate/environment activist who wants to get a handle on municipal politics.

The novel follows three well-meaning people – a policewoman, a senior council officer and a public health officer - as they untangle a web of crimes and corruption. They are all-too-human, with different strengths and weaknesses, and different abilities to play the games that need playing to get anything done. The author is particularly good on how the micro-politics of alliance-building, and how a focus on facts and "shoulds" can lead to the opposite outcomes to those that, ahem, "should" be happening.

But forget the "worthy" reasons you should read it; it's ALSO a perfectly good read! The characters are well-drawn, their thoughts and actions believable, the descriptions of the quiet menace of a drunken town on a Saturday night unsettlingly familiar. The chapters (dated and timed and usually following - one of the three main characters) are short and pointed. There's thrills enough (believe it or not – the whole idea of a "Town Hall thriller" seems odd, I know); the "political" climax is rousing and thought-provoking, the "woman in jeopardy" climax also extremely well done. Dawn Reeves is definitely an author to watch.
