# WHAT'S OUR FUTURE?

On Thursday 23rd of September the Sustainable Neighbourhoods Action Group (http://snag.org.uk) is hosting an event entitled "Manchester: What's Our Future." Starting at 7.30pm, it takes place at Nexus Cafe, Dale St, in the City Centre. It will be a great opportunity for MCFly readers to learn more about the Manchester Climate Change Action Plan and what they can do to make all the fine words in it into reality.

SNAG tells us that "there'll be lots of people there to answer all your questions, including representatives of many of the organisations that helped write the plan such as MERCi, Friends of the Earth, Action for Sustainable Living, the Kindling Trust, Call to Real Action, Manchester Environmental Education Network, Corridor Manchester, Emerge, Creative Concern, BDP, Gaby Porter Associates and Pannone, as well as representatives from Manchester City Council for you to quiz! There'll also be space for you to have your say on how WE should shape our city's future. And film, fun and lots of tasty FOOD."

As well as being a great learning opportunity, this event also marks the start of a series of "fringe" events aimed at explaining the strengths, weaknesses and silences in the Manchester Climate Change Action Plan and the Council's now-delayed "Internal Delivery Plan."

These other events are being organised by groups as diverse as Action for Sustainable Living, Call to Real Action, Friends of the Earth, the Green Party and the Kindling Trust

### How should we tackle cllimate change? Your opinion sought!!

- 1) How can Manchester City Council help you (as an individual/employee/member of a group) to take action on climate change?
- 2) What should the City Council be doing about climate change? The Council will try to reduce its emissions by 41% by 2020, and help create a 'low carbon culture'. In your opinion, what should the Council do to reach those goals?

#### **ENDORSEMENTS? FLYING MONKEYS!**

MCFly is still trying to find out who has endorsed the "Manchester Climate Change Action Plan." Several times we've been told an announcement is imminent. Sick of the whole "Waiting for Godot"

aspect, we asked directly. And were given the lovely circular and Kafka-esque answer "As soon as we have the agreement of all the endorsers and are ready to launch phase 2 of the website, the full list will be made public." Look, an endorsement that is only between the so-called endorser and the Council is NOT an endorsement. A "private" endorsement is like a monkey with wings. You can imagine such a thing, but it's a bit bloody pointless.

We also wanted to know how many organisations have been approached. But the Council "cannot provide a definitive number of organisations who have been approached - because the approaches are being made by a range of individuals and organisations who have signed up to support the plan" but are "sure that the number is larger than the 1067 originally approached." Ok, that's fair enough. Let's say for the sake of argument that, ooh, 1100 organisations have been asked. The Council "believe we have 110 organisations signed up". Er, MCFly pulls out its ol' solar-powered calculator. Yep... 10%. In the crucial 10 months after the plan is launched, when momentum and social validation is all. 10. per. cent.




Nothing to report on the "Steering Group" (see MCFlys passim). No news if the academic or business bod have accepted the invite to join up. However, MCFly CAN report that the November 30 "stakeholder conference" is NOT going to be a full-day event (despite what we were told and dutifully reported in MCFly 54). It is now going to be a *half*-day event, topped and tailed with speeches by Very Important People. Venue? Dunno. Means by which you can sign up to attend? Dunno. If and when we get reliable information, we'll let you know.

#### **MANCHESTER CITY COUNCIL KEEPS BREAKING LAW (reprinted from MCFly 55)**

Manchester City Council is STILL breaking the law (see MCFly 54). MCFly submitted a Freedom of Information Act request about flights taken by Council officers and members in 2008/9 and 2009/10, and any off-setting arrangements that had been made. We received a pro-forma letter promising a reply within the statutory "20 working days", which meant late July. Since then ... nothing. Either they have something to hide, or they just don't give a rat's arse about establishing a reputation for honesty, transparency and respect for Freedom of Information. Which is it, we wonder.



**BOLTON** is to host a conference highlighting the work of local agencies, charities and organisations to tackle climate change. #### **WIGAN Peerless**

WiganRecycles has won The Community Challenge in Low Carbon Transport. The award received 83 applicants in total, only 23 were short listed, and out of these Wigan Recycles was chosen for its pilot Eco Drive scheme which was designed and delivered by Future Jobs Fund employees. The scheme, which helps drivers to increase their fuel efficiency and general maintenance of their cars, was delivered to Ashton, Leigh & Wigan PCT staff. Judges found that the scheme displayed strong merits in both its innovative reduction of carbon emissions and its effects on employment and the lives of young people. The award was presented at the LowCVP annual conference at Twickenham Stadium.



#### "Foundation" in replying to MCFly email shocker!!

Last year MCFly tried to get answers out of "Kro Bar" and "Foundation" about the details of the pre-Copenhagen "sponsorship" tie-in between the glass-and-chrome yuppie watering holes and the struggling 'offset' outfit. We were blanked, and later told by someone at the latter that a "least said, soonest ended" policy had been adopted.
