## IN THE CUT\*

Action for Sustainable Living (AfSL), a charity that helps individuals and communities make reductions in their carbon emissions, has suffered a major financial blow at the hands of Manchester City Council. Ten weeks before a major conference on the Manchester Climate Change Action Plan, the City Council has ... decided not to renew its funding of the work they do.

AfSL have confirmed they have "a number of contracts across Greater Manchester harnessing the passion, enthusiasm and skill of volunteers to promote sustainable living, in all its aspects, in their own communities. One of those contracts, with Manchester City Council, has come to an end. This decision will have an impact on a small number of areas within the City although our Reaching Communities programme in South Manchester will continue."

The City Council has adamantly objected to the use of the word "cuts", and in response to a very specific set of questions have chosen instead to answer questions that were not in fact asked. They do concede that "the time-limited project funding for a number of projects, including some run by AfSL, has come to an end, and these projects are now in the process of being completed."

So - let's be clear; weeks before the stakeholder conference (see page 2), it is going to get harder for stakeholders to take action to live sustainably thanks to these financial decisions. The Council - which had not objected to the use of the word "pulled" - may be nervous about its record. It announced £1 million in February 2008, barely spending a penny of that "Carbon Innovation Fund" until July 2009 and then using a hundred grand on a climate festival nobody can remember. It has not renewed the Carbon Innovation fund.

## FOUNDATION:

As reported in MCFly 57, we emailed the carbon offset outfit Foundation (www..foundation.climatefund.org.uk) on Friday 3rd September.

"Manchester Climate Fortnightly is going to run a story on the amount of money generated for Foundation from the "tiein" with Kro Bar. It has been suggested to us by a confidential source that this sum is a great deal smaller than had been anticipated. We would like to know

- what target amount was anticipated in the original agreement with Kro?
- what is the amount raised to 31 August?
- is the agreement under review?"

Within an hour top bod MarkTurner replied "Thank you for your query. As I'm sure you will appreciate I will need to gather a few facts and figures before I can fully respond to your request (especially the second point raised). I'll get on with this & hope to get back to you early next week."

We waited not a few days, but almost a month. First thing on Friday 1st October we wrote again, stating that we were still waiting for the promised reply. We wrote "[I]n addition to the original questions, which are still of great interest to

## MANCHESTER CITY COUNCIL KEEPS BREAKING LAW (reprinted from MCFly 55, 56 ... and 57)

Manchester City Council is STILL breaking the law (see MCFly 54). MCFly submitted a Freedom of Information Act request about flights taken by Council officers and members in 2008/9 and 2009/10, and any off-setting arrangements that had been made. We received a pro-forma letter promising a reply within the statutory "20 working days", which meant late July. Since then... nothing. Either they have something to hide, or they just don't give a rat's arse about establishing a reputation for honesty, transparency and respect for Freedom of Information. Which is it, we wonder?

#### A Climate Change Strategy for Greater Manchester

The production of a Greater Manchester Climate Change Strategy has been agreed by the "Association of Greater Manchester Authorities" (AGMA) at its September meeting. This will collate existing theme and district plans into a single strategy which will underpin the Greater Manchester Strategy agreed in July 2009. As well as advancing joint working between themes and districts, the timing of this piece of work will also enable GM to adjust to other changes arising from climate change policies and programmes being implemented by the new Government.. The development of the strategy will be undertaken by a task group led by Richard Sharland (Head of Environmental Strategy at Manchester City Council). Work will be carried out in two phases - a draft document by January followed by a consultation process to April/May.



Invites are apparently going out in three waves. First to those who aren't the usual suspects, then to the endorsing organisations (see below) and finally to the general public. We asked; "when, and how the public will be able to sign up to attend? When will they know if they have been successful in their application? What criteria are being used to select attendees?"

Answers are still pending. Interesting for anyone keen but needing to book annual leave from work, f'rinstance. Eight weeks away... Five key questions will be asked to stakeholders and partners in the run up to the conference. These will help the organisers arrange the workshop and marketplace area.

- 1. Tell us what you are doing that deserves to be more widely communicated? Choose one story that encompasses your successes.
- 2. What barriers have you encountered that as a city we could tackle together?
- 3. What does your next phase of action look like?
- 4. What connections could you make to further your work? New partners? Other sectors? Other communities?
- 5. How can we collectively recruit more people to aid our progress?

Who has (privately) endorsed the plan? We still don't know, (not for want of asking - for over 4 months now). Perhaps it is being saved to be a "mingling tacite" on the Big Day; a "find three other attendees who've endoresed the Plan" sort of thing.

## Richard Leese acknowledges aviation is bad for environment!

Responding to a comment on his blog post "Commuting Nightmare", (www.manchester.gov.uk/blog/leadersblog/post/395) Council Leader Richard Leese has asked a question "how are you getting to Australia?" that logically concedes aviation pollutes. So, it's to be welcomed, even if it was a tin-eared attempt to divert from the issue at hand - when is Manchester City Council going to make explicit provision for counting international aviation emissions in its carbon reduction targets? It's a good question... Don't go holding your breath for an answer...

#### Democracy, Accountability and Transparency; It's the "Manchester Way."

The Manchester Board, made up of various worthies, meets four times a year, ostensibly to guide the Local Strategic Partnership (www.manchesterpartnership.org.uk). It met in July, and presumably agreed the April minutes as a fair and accurate record blah blah blah. But these April minutes have still not been posted on the website. They Have Form; MCFly raised this with a previous set of Board minutes. It's almost as if openness and letting the oiks see what is going on is not a priority.

## A heart-breaking work of staggering... idiocy

The 10:10 organisation encourages individuals and organisations (Manchester City Council has signed up) to cut their carbon emissions by 10% in 2010. On Friday October 1st they briefly posted a youtube video directed by Richard "My films are cloying sentimental tosh, Actually" Curtis. In it, people - including school children - who were reluctant to "do their bit" were, well, **blown up.** 

This gift to those who think climate campaigners are all ecofascist jihadis got taken down quickly, but is of course all over the blogosphere. A representative comment - "It's safe to conclude that your disgusting filthy little snuff video of a propaganda stunt

## It's the Green Party and you can cry if you want to

MCFly 57 (published Sunday 26th September) reported that Gayle O'Donovan would be standing for the Green Party in the Hulme by-election forced by the resignation of sitting councillor Emily Lomax. Two days later MCFly's website reported that Ms O'Donovan had stepped down and that the Greens would now be fielding David "Hazel must go" Henry as a candidate. Mr Henry had to step down (he is not eligible). Another candidate was mooted, but there were possible trust issues with 51% of the electorate. The Green Party has now announced Deyika Nzeribe as their (final) candidate, and tell us "Deyika's work is helping people back into employment and in setting up cooperatives. He has lived in Hulme for ten years and is active in the Birley Fields campaign and in anti-racist campaigning."

Meanwhile the Liberal Democrats are contesting the ward vigorously (in May they ran a 'paper' candidate). Even meaner and even whiler, Labour activists - including Executive Member for the Environment Nighel Murphy, who is a Hulme Councillor - are out knocking on doors and (figuratively) kissing babies on behalf of their peripatetic serial candidate Amina Low. The by-election takes place on Thursday November 4. MCFly will ask all the candidates about their climate views and duly report.
